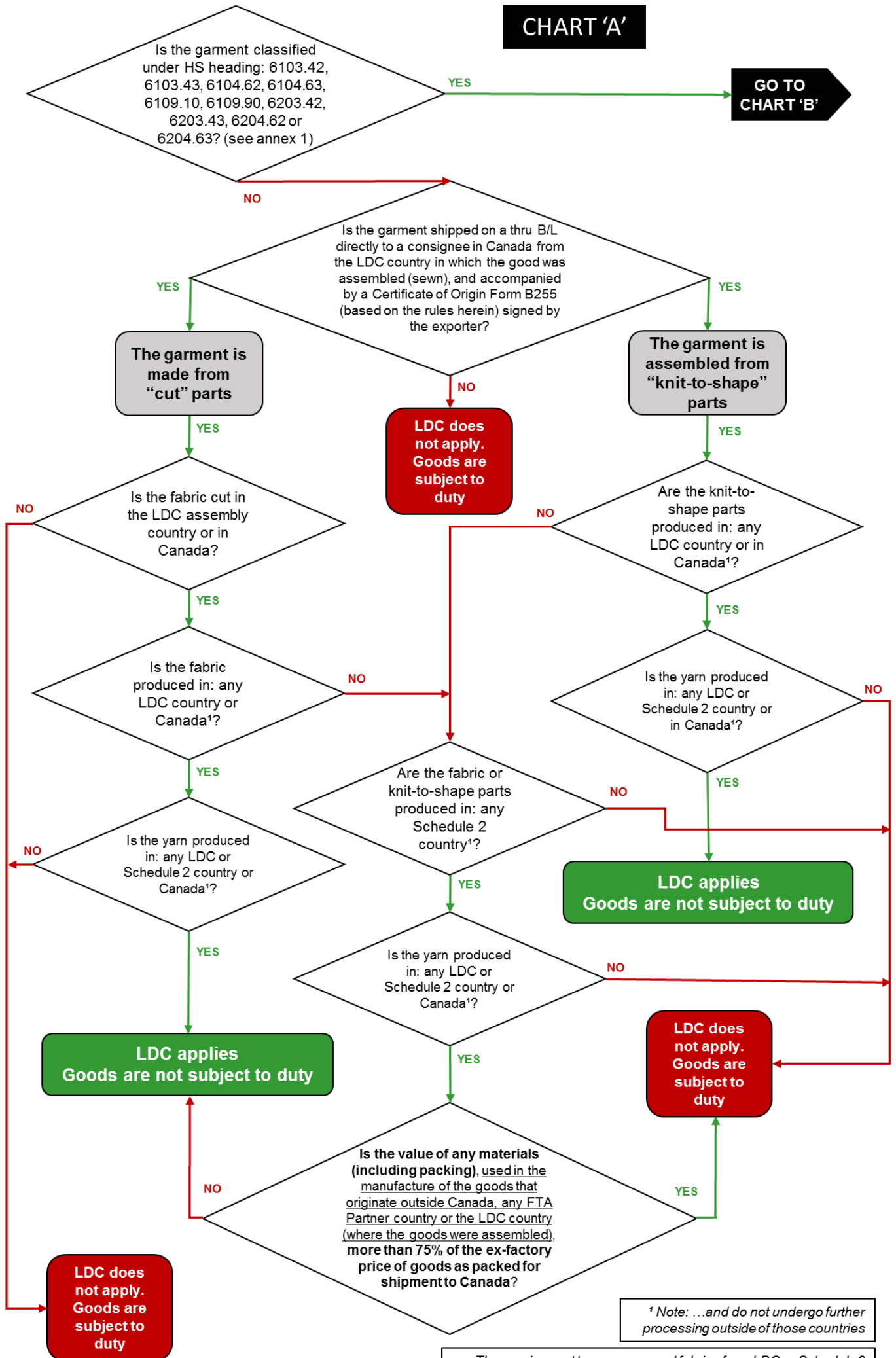


Decision Chart to Determine LDC Eligibility for Textile Wearing Apparel

CHART 'A'

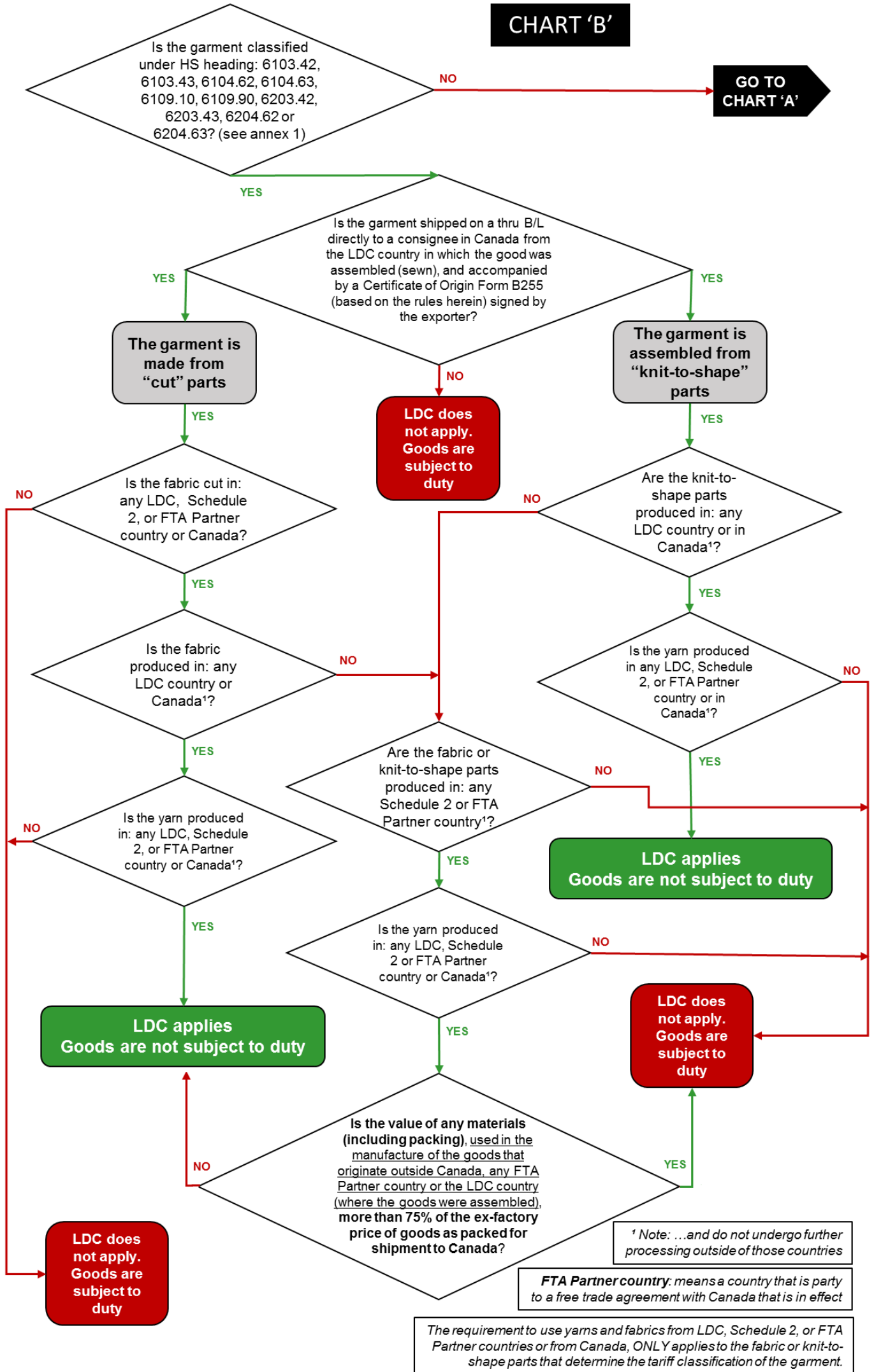
